Full SonicSite License Agreement

THIS IS A LEGAL AGREEMENT BETWEEN YOU AND SONICSITE. BY USING THE FILES PROVIDED WITH THIS DOCUMENT YOU AGREE TO BE BOUND BY THIS AGREEMENT.

For the purpose of this Agreement the term "The Content" shall mean any audio file, musical composition, Flash soundtrack, and sound effect recorded and delivered in any format.

GRANT OF LICENSE. SonicSite grants you the non-exclusive, non-transferable license to use and modify The Content subject to the restrictions contained herein.

This License Agreement **DOES PERMIT** the following uses of The Content. You may use The Content in your audio, web, animation, multimedia or video projects including advertisements, PowerPoint presentations, and streaming broadcasts. You are permitted to re-sell these projects to a third party customer as long as The Content is embedded in the project and is copy protected.

This license Agreement **DOES NOT PERMIT** the following uses of The Content. You may not post The Content on any electronic bulletin board or place The Content on-line in a downloadable format. The Content may not be copied in its entirety. You may not re-sell, rent, transfer or grant any rights to The Content itself to any other person (other than the provision stated below) or organization without prior written consent of SonicSite. The content may be distributed within the same company within a network or similar asset management system to individuals within the company or similar legal entity.

Using The Content in a way not covered by this Agreement or that is specifically prohibited, without prior written consent from SonicSite, is a violation of Federal copyright law. This license is in force until it is terminated. If you do not comply with the terms and conditions above, this license automatically terminates. At termination, the product must be destroyed or returned to SonicSite immediately.

COPYRIGHT. All The Content is copyright SonicSite or its licensors and is protected by the United States Copyright laws, international treaty provisions and other applicable laws. No title or intellectual property rights in The Content is transferred to you. SonicSite Retains all rights not expressly granted by this license Agreement.

To prevent unauthorized re-use of The Content and to protect yourself from liability, it is strongly recommended that the following warning message be included in each of your productions: "WARNING: UNAUTHORIZED USE OF THE MUSIC AND AUDIO CONTENT CONTAINED IN THIS PRODUCTION IS SUBJECT TO CRIMINAL PROSECUTION. LIMITED WARRANTY. SonicSite warrants The Content to be free from defects in material and workmanship for 30 days from delivery. Your sole and exclusive remedy for a breach of this warranty is the replacement of The Content or a refund of the purchase price, at the option of SonicSite.

SonicSite makes no other warranty nor agrees any other condition, representation or undertaking, either express or implied, of any nature, including as to merchantability, satisfactory quality, fitness for any particular use or compatibility with any computer or other kind of equipment. Neither SonicSite nor any of its agents or employees shall be liable to any distributor or other reseller, customer, end user or other person or any indirect, incidental, special or consequential damages (including loss of profit, business, revenue, goodwill or anticipated savings) resulting from its

performance or non-performance of this Agreement or the use of, or inability to use, The Content provided under this Agreement or arising (or which might be claimed) under any other cause of action or theory of claim. Moreover, the liability of SonicSite, its agents and employees in respect of any other cause of action (whether arising in tort, contract or otherwise and notwithstanding any negligence or other fault) shall in no event exceed the sales value of The Content. Some jurisdictions do not permit the restriction of liability in respect of death, personal injury, deceit nor the exclusion of certain implied conditions and/or warranties and, accordingly, the liability of SonicSite shall not be restricted to the extent that this is not legally permitted.

GENERAL PROVISIONS. This Agreement will be governed by the laws in force in the State of Massachusetts excluding the application of its conflicts of law rules. This Agreement will not be governed by the United Nations Convention on Contracts for the International Sale of Goods, the application of which is expressly excluded. If any part of this Agreement is found void and unenforceable, it will not affect the validity of the balance of the Agreement, which shall remain valid and enforceable according to its terms. You agree that The Content will not be shipped, transferred or exported into any country or used in any manner prohibited by the United States Export Administration Act or any other export laws, restrictions or regulations. SonicSite reserves the right to discontinue the license of The Content, for any reason and to elect to replace The Content with an alternative. Upon notice of any discontinuance of a license you, and your employer and your client if applicable, agree not to further use The Content so discontinued.

This Agreement shall automatically terminate upon failure by you to comply with its terms.
